





CITY ORDINANCE 09-086

TITLE: **AN ORDINANCE DEDICATING THAT THE SOUTHEAST CORNER OF  
MARTIN LUTHER KING DRIVE AND ARMSTRONG AVENUE ALSO BE KNOWN  
AS BISHOP CLYDE L. HARRIS WAY**

*The Municipal Council of the City of Jersey City does hereby ordain:*

**WHEREAS, Clyde L. Harris** was born on May 25, 1926 in Wake County, North Carolina. He was the fourth of eight children born to the late George C. Harris and Bertha Harris. Clyde attended Public School and Bero Kelly High School; and

**WHEREAS, Clyde L. Harris** had a heart to serve his county and community. He joined the army in 1944 during World War II and received an Honorable Discharge in 1946. He went on to work at Duke University Hospital as an orderly until he relocated to Jersey City. **Clyde L. Harris** continued community work by teaching carpentry in his new neighborhood; and

**WHEREAS, Clyde L. Harris** in 1951 Clyde met Bishop Jose Linares in 1951 and was encouraged to visit his church, St. Mary Evangelical Christian Church #2, located in Brooklyn, New York. **Clyde Harris** served his church and community faithfully; and

**WHEREAS, Clyde L. Harris** was called to the ministry in 1963 and admitted to the 35<sup>th</sup> Annual Council of the Evangelical Christian Church as an Elder on September 26, 1965. Somewhere between 1969 and 1971, St. Mary Evangelical Christian Church purchased a building at 791 Ocean Avenue in Jersey City, N.J. St. Mary relocated to its present site at 90 Martin Luther King Drive in 1973; and

**WHEREAS, Elder Harris** was appointed overseer for the Christian Connections' Board of Elders in 1983. Subsequently, he was elected Bishop by Bishop Linares and the Evangelical Christian Connection and officially installed in January 1984 as Bishop and Superintendent of the Evangelical Christian Connection Inc.; and

**WHEREAS, Bishop Harris** has opened the doors of the church to the community on many occasions. The church has served as a safe haven to many, a place of counseling & a food Bank for the needy. St. Mary has hosted Health & Senior Awareness Seminars, Health Maintenance Seminars, Summer Bible School, Block Association meetings, and Teen Pregnancy Awareness Programs. Outreach Services are often conducted outside the doors of the church from July to September and the list goes on; and

**WHEREAS, Bishop Harris** desires that his church be a beacon in the community where those who are in despair are able to come in and be uplifted, and walk away with hope. It's about being saved and knowing that Jesus is the answer.

**NOW THEREFORE BE IT ORDAINED**, that the southeast corner of Martin Luther King Drive and Armstrong Avenue also be known as **Bishop Clyde L. Harris Way**

ARTICLE II (COUNCIL) OF THE JERSEY CITY CODE ESTABLISHING THE

THE MUNICIPAL COUNCIL OF THE CITY OF JERSEY CITY DOES ORDAIN:

A. The following amendment to Chapter 3 (Administration of Government) Article II (Council) is hereby adopted:

**CHAPTER 3  
Administration of Government**

**Article II  
Council**

§3-4 Organization; President; President Pro Tem


- A. The Council shall organizer pursuant to law on July 1 at which time it shall elect a President from among its members for a term coextensive with the term of the Council; provided, however, that the election of July 1, 1994 shall be for a term of three years.
- B. The Council may also elect a Council President Pro Tem from among its members for a term coextensive with the term of the Council.
