offered and moved adoption of the following ordinance:

CITY ORDINANCE 10-069

**TITLE: ORDINANCE ABOLISHING THE ELLIS ISLAND COMMISSION,
HUMAN RIGHTS COMMISSION, THE MUNICIPAL DRUG &
ALCOHOL ABUSE ALLIANCE, AND THE TOURIST COMMISSION**

A. The following abolishment of the Jersey City Municipal Code is hereby adopted:

WHEREAS, the City of Jersey City desires to appoint and staff all boards, agencies, and commissions that are authorized by state statutes, are properly constituted, and serve important governmental functions; and

WHEREAS, the City Clerk is responsible for maintaining the list of boards, agencies, and commissions, as well as, the names and terms of individuals serving on same. Through review, it has become evident that boards and commissions no longer serve important government functions and have been left unfilled for a number of years. These defunct boards and commissions include:

- The Ellis Island Commission;
- The Human Rights Commission;
- The Municipal Drug & Alcohol Abuse Alliance; and
- The Tourist Commission

WHEREAS, it is important to City government to maintain and update appointments and terms of service to the various boards, agencies, and commissions in the City, it is also important to do away with entities that no longer serve an important governmental function.

NOW, THEREFORE, BE IT ORDAINED, by the Municipal Council of the City of Jersey City that:

The Ellis Island Commission, The Human Rights Commission, The Municipal Drug & Alcohol Abuse Alliance, and The Tourist Commission will now be deleted from the list of boards, agencies, and commissions maintained by the City Clerk.

B. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

C. This ordinance shall be a part of the Jersey City Code as though codified and fully set forth therein. The City Clerk shall have this ordinance codified and incorporated in the official copies of the Jersey City Code.

D. This ordinance shall take effect at the time and in the manner as provided by law.

E. The City Clerk and the Corporation Counsel be and they are hereby authorized and directed to change any chapter numbers, article numbers and section numbers in the event that the codification of this ordinance reveals that there is a conflict between those numbers and the existing code, in order to avoid confusion and possible accidental repealers of existing provisions.

ON SATURDAY, EXCEPT HOLIDAYS; AMENDING ARTICLE X (SCHEDULES) SCHEDULE 17 (NO STOPPING OR STANDING) REPEALING THE NO STOPPING OR STANDING PROHIBITION ON THE SOUTH SIDE OF GRAND STREET BETWEEN RIVER STREET (PRIVATE ROADWAY) AND TIDEWATER STREET (PRIVATE ROADWAY) AND AMEND SCHEDULE 4 (NO PARKING DAILY, EXCEPT SUNDAYS AND HOLIDAYS) DESIGNATING NO PARKING 7:00 A.M. TO 9:00 A.M. MONDAY THROUGH FRIDAY ON THE SOUTH SIDE OF GRAND STREET BETWEEN RIVER STREET (PRIVATE ROADWAY) AND TIDEWATER STREET (PRIVATE ROADWAY)

THE MUNICIPAL COUNCIL OF THE CITY OF JERSEY CITY DOES ORDAIN:

1. Chapter 26(Vehicles and Traffic) Article V (Metered Parking) of the Jersey City Code is hereby supplemented as follows:

Sec. 26-28 Parking Meter Zones

 - (A) (B) Douglas and Arthur Skinner Memorial Drive (FKA: Jersey Avenue), both sides Grand Street to the southern terminus
 - (C) Grand Street, South Side between River Street (Private Roadway) and Tidewater Street (Private Roadway)

- (b) (2.1) No Change
- (2.2) No Change
- (2.3) Parking or standing a vehicle in a designated space in the parking meter zone on the south side of Grand Street between River Street (Private Roadway) and Tidewater Street (Private Roadway) shall be lawful for two(2) hours in twenty (20) minute intervals upon the required deposit in the parking meter adjacent to the parking space for those hours specified in this section.

2. Chapter 26(Vehicles and Traffic) Article X(Schedules) of the Jersey City Code is hereby supplemented as follows:

No person shall park a vehicle between the hours specified any day (except Sundays and public holidays) upon any of the streets or parts of streets described.







GRAND STREET BETWEEN RIVER STREET AND TIDEWATER STREET

Attached for your review and signature is an Ordinance proposed by this Division at the request of Councilman Fulop on behalf of Liberty Harbor North supplementing Chapter 26 (Vehicles and Traffic) of the Jersey City Municipal Code. The proposed ordinance designates the following parking restrictions on the south side of Grand Street between River Street (private roadway) and Tidewater Street (private roadway).

- Designate a Parking Meter Zone, on the south side of Grand Street, between River Street (private roadway) and Tidewater Street (private roadway) from 9:00 a.m. to 9:00 p.m., Monday through Friday, and 9:00 a.m. to 5:00 p.m. on Saturday, except holidays. A vehicle can park for two (2) hours, in twenty (20) minute intervals, upon the required deposit in the parking meter adjacent to the parking space
- Designate "no parking" 7:00 a.m. to 9:00 a.m., Monday through Friday, on the south side of Grand Street between River Street (private roadway) and Tidewater Street (private roadway)
- Repeal the "no stopping or standing" on the south side of Grand Street between River Street (private roadway) and Tidewater Street (private roadway)


